## WSRC and DVR Collaborate on Comprehensive Needs Assessment

DVR and the WSRC continue to make progress on our collaboration on a comprehensive needs assessment. Together we (have completed or) are undertaking a range of assessment activities between now and May. The goal is to position DVR to better understand and meet the

needs of employers and in doing so, to support jobseekers with disabilities to secure work in fields with potential for advancement and wage progression.

We are collaborating with the Association of Washington Business on an employer survey and together we will facilitate customer focus groups and public meetings.

## Jim Larson to Chair WSRC in 2009

Few Rehabilitation Councils in the nation are as fortunate as the WSRC has been to have a knowledgeable, dedicated representative of the Workforce Training and Education Coordinating Board like our own Martin McCallum. McCallum continues to make significant contributions to the success of our Council. In January Martin McCallum concluded his term as Council Chair.

Jim Larson was elected by his peers to succeed Martin McCallum as the 2009 Council Chair. Larson was appointed to the Council by Governor Gregoire in 2007.

He is a seasoned leader and manager who has built

his career supporting people with disabilities to secure employment. Jim Larson is the President and Chief Executive Officer of Morningside, a Community Rehabilitation Program serving jobseekers with disabilities in Thurston and Grays Harbor Counties. He has been at the helm of Morningside since 1989. Larson led two other employment programs including one based in Ellensburg which he transformed from a facility based program to a community based program.

Jim was born and raised in Ballard. He is a graduate of Western Washington University. Jim Larson has a long record of civic engagement and volunteer service. He served on our Council for the first time from 1995 to 2000. Larson has served as the Chair of the Council in the past.

## Welcome Aboard Don Brandon

The members and staff of the WSRC are pleased to welcome Don Brandon as our newest member. Brandon represents the perspectives of current and former customers of DVR on the Council. He brings a breadth and depth of leadership experience and relationships to his Council service. As the Director of the Disability Business and Technical Assistance Center Northwest, Brandon is a regional liaison to the community of employers and can provide the much needed practical assistance that many entrepreneurs seek when making their businesses and employment opportunities more accessible.

Prior to his service with the Disability Business and Technical Assistance Center, Don Brandon served as the ADA Officer for the State of Alaska. He also worked as the ADA and Affirmative Action Officer for the University of Alaska at Anchorage, and was the longtime Chair of the Governor's

Committee on Employment and Rehabilitation for our neighbors to the north. When asked to comment on her colleagues' leadership style Kathe Matrone, the Director of the Technical Assistance Continuing Education grant at the University of Washington said of him, "He's an action-oriented person, a character, very personable and well-positioned to be a conduit to the employment community."

In addition to his professional domain, Brandon has been active in advancing the goals of the Independent Living Movement and widely involved with accessible recreation activities. He co-founded the Fairbanks to Anchorage wheelchair race and was among its earliest winners. Don Brandon will attend his first Council meeting in April in Silverdale.

## Seeking Customer Input and Hosting 'Say Hey Kitsap'

The WSRC has a two part federal mandate to garner input from DVR customers and to assess their satisfaction with the DVR services. Over the past four years, one way we have sought information from the customer base has been by hosting quarterly customer forums. Since the end of the waiting list for services last year we have noticed a marked decline in attendance at the forums.

We are seeking new strategies to draw

customers and other stakeholders to share their successes, insights and concerns.

During the April quarterly meeting we are allocating time in the afternoon for comment. Some of the approaches we are considering are: Extending personalized invitations to a small random sample of customers, who are in a particular phase of the VR process and asking them to reflect on a prepared set of questions; allocating time for less structured comment from others with open cases in the county;

and coordinating opportunities for virtual participation via conference calls or video conferencing.

The Council is also organizing the inaugural 'Say Hey Kitsap' to immediately follow the public comment period in the hopes of creating additional incentive to attend.

## Orion Industries Highlights Promise of Project with Industries Grant

At the January quarterly meeting Kathy Powers, the Director of Rehabilitation Services for Orion Industries joined us to discuss the work of her organization.

Orion Industries provides on the job training for people in King and Pierce Counties. Orion serves program participants who have been unemployed or underemployed for a variety of reasons. Orion Industries fabricates machined parts for the aerospace industry. They also are making inroads into the field of healthcare, clerical support, and customer service. Recently Orion

secured a *Projects with Industries* grant from the Rehabilitation Services Administration. The target populations for grant funded services are people with disabilities or others with low educational attainment and a history of criminal or civil non violent offenses. DVR serves to benefit from the grant because it will not have to purchase the services Orion offers and because the grantee will be working closely with a Business Advisory Council that will help DVR to connect with employers.
